Looking at doing paving next month.In the event that we get a lot rain from the storm that is coming, crew and I have prepared as much as possible.

TOWN CLERK- Sheila Paul: Reached out to other Clerk's regarding online bill pays, and some do pay utilities bills online. I am asking the board for approval to pay utilities bills online. Hospital- Muratore/ Wilson: NYSG&E is looking into the charging station to be placed at the hospital. Terri Tweedie from Delaware County Office for the Aging will be doing a Tai Chi class on Tuesday and Thursdays from 11:00 to Noon starting on October 8th until December 19th, 2024. It takes place near the Senior Center on the second floor of the hospital.

Insurance-Heath / Greene: Mr. Greene received a quote from our Insurance company to cover the playground equipment in Sidney Center. The cost was additional \$10.00 for the year. Mr. Greene made a motion to accept the increase of \$10.00 to cover the playground equipment, it was seconded by Mr. Wilson and carried. AYES: F. Selleck, B. Heath, P. Muratore. NAYES: None

Mr. Heath contacted NYSE&G about power for the playground, and the lighting adjacent to the park is not metered, it would have to be a new service, which is very costly.

Zoning & Planning- Muratore/ Selleck: Working on Campgrounds. Meeting is held every 3rd Monday of the month.

East Sidney Lake- Heath/ Selleck: J. Nolan manager stated that NYS Dept of Heath inspector the grounds and found no infractions, but water test for the lake, did come back with bacteria.

Playground equipment will be assembled when weather permits.

The new mower has been delivered and has been up and running.

Monitoring water levels, due to the upcoming rain.

Mr. Selleck stated that Ed Backus plaque for the pavilion is ready and needs to be placed in the pavilion.

Finance: Muratore/ Wilson: Supervisor Wilson stated that there are some T-bills that are coming mature and will be emailing the board options and come to a consensus of what should be done with the money.

IT- Wilson/ Muratore: P. Muratore proposed to update the wireless infrastructure for the Town Building to bring in 5G network. He stated that it will help with security. The Cost would be \$ 1,465.00. Motion was made by Mr. Muratore to update network and seconded by Mr. Wilson and carried. **AYES:** F. Selleck, B. Heath, K. Greene. **NAYES:** none

Looking at installing video surveillance for security purposes at the Hospital, this would include 5 cameras and the cost would be \$ 3,000. Motion was made by Mr. Wilson to move forward installing the camera and it was seconded by Mr. Heath and carried. **AYES**: F. Selleck, K. Greene, P. Muratore. **NAYES**: None

Justice: Greene/Heath: Town Attorney Mr. Ermeti stated that that the county is considering a Traffic Diversion Program. The program would allow drivers with low level traffic offenses to take an online course. The online course would all them from having to pay a fine and avoid getting points of their license. It would reduce the workload for the district attorneys and courts. Delaware County Supervisors are to vote on this program on August 28, 2024. Chenango and Otsego counties already have program in place.

K. Greene has met with Judge McCann to discuss helping to apply for a grant through the Justice Court Assistance Program. Program helps local courts to obtain money for court improvements, the maximum award is \$ 30,000.

DCO: Greene: There was incident on Cover Bridge Road with two rottweiler with councilmember Selleck, that the dog control officer had to address.

Also, there is an agreement that campers have to sign the no underage children will be allowed to drive golf carts, but there are children driving recklessly through the park. Campers are unable to make complaints at the park, as there are no staff to contact. John Nolan: Park's manager stated that it has been difficult to find people to work. Currently there is one full-time and two part-time maintenance people, five office employees and himself. He typically has the office open from 8:00 a.m. to 8:00 p.m. but has been short staff at times.
