PUBLIC HEARING: At 7:02 p.m. Mr. Wilson called to order a Public Hearing with speaker Charles Bailey on applying for a Community Development Block Grant.

Mr. Bailey from Delaware Opportunities spoke about applying for a Community Development Block Grant and the total of the Grant money would be 750,000 for the municipality from a pool of 2.25 million.
