Eddie Pigford, present the Town Board a book that was written by her late husband and Town Supervisor Gene Pigford. The title is "Let Me Fly Higher."

Sidney Central School Flood Monitoring and Weather Forecasting enrichment program, which is headed up by Richard Townsend. Program was created after the 2006 flood, which was devasting to the area. Mr. Townsend applied for a grant and received \$ 150,000 from State Farm Insurance Youth Advisory Board. This grant was used to develop a flood-monitoring network over the upper portion of the Susquehanna River Watershed, which includes eight solar-powered satellite linked in reporting. The flood gauges played a critical role in the 2011 flood. The devices do need to be replaced after two decades. The group have received a \$ 5,000 grant from the Susquehanna River Basin Commission and other funding but are looking for other funds to support in purchasing one more SatLink 3 Lite device.
