HIGHWAY- Highway Superintendent Codey Lambrecht: Paving projects are completed. Roads are in decent shape heading into the fall and winter seasons.

Crew is currently working on Gallop Hill Road, doing ditching for drainage and regarding the entire road.

Tom Hunt will be retiring after 27 years from the Highway Department. Tom's last day will be October 16, 2025.

With the retirement of Tom Hunt, we have an open position on our crew, and I will be asking Sheila to place an ad in The Report for the next two weeks. My goal is to have new hire in place and training starts in mid-October.

Winter is approaching faster than we think and we want to ensure that we have a fully trained team, which is essential for safe and effective snow and ice response.

SUPERVISOR- Eric Wilson: Nothing to report.

TOWN CLERK- Sheila Paul: Clerk training from September 20th to September 22, 2025.

There will be the first Budget workshop on Thursday September 25th at 6:00pm.

Mr. Selleck spoke that he did an in-house audit in the Town Clerks office, and all accounts are in order.

REPORTS

<u>Highway: Frank Selleck/ Eric Wilson:</u> There have been three meetings and tough negotiations with the Teamsters and have come to an agreement. The board will discuss it in Executive Session.

<u>Hospital: Paul Muratore/ Eric Wilson:</u> Supervisor Wilson stated that there might be a new tenant at the Hospital.

Supervisor Wilson also spoke about two roofs that need to be replace. One is 25 square foot section, and the other is 150 square foot section. One section is 20 years past due. They will be going to bid soon.

Bassett Healthcare has signed a three-year lease.

<u>IT: Eric Wilson / Paul Muratore:</u> Mr. Muratore announced that the Clerk's server crashed and that the server is over seven years old. Judge McCann asked at the meeting how the program works, Judge McCann stated that there is extra paperwork now, but it should eventually make things easier. The town gets 80% of the fines and the County gets 20%.

Resolution Authorizing JCAP Grand Application: Judge McCann requested approval to apply for a Justice Court Assistance Program. (JCAP) grant. The state program provides limited funding to improve the operation of the Court. Judge McCann would like to upgrade the computer system. Grant is up to \$30,000.

UNFINISHED BUSINESS

Mr. Greene stated that the Community Development Block Grant (CDBG) application is ready for final submittal. This Grantis specifically for Town residents.

Mr. Greene also stated that hopefully the Village will apply next year for the grant.

COMMENTS FROM THE FLOOR

A Sidney resident wanted to know why the Town board had put off replacing roof on the hospital for so long. Supervisor Wilson stated that majority of the roofs on the hospital have been replaced. The two sections of the roofs been patched over the years. At this time, they need to be replaced. Supervisor Wilson also stated that the Town can only do so much within budget constraints.

Resident Lois Green thanked the council members for voting to allow a cannabis dispensary in the Town of Sidney. Green's Greenery, managed by her grandson Travis Andrews and owned by his mother Kate Andrews and grandmother. The Town receives 3% of the 4%. The recent quarter the town received. \$22.434.49.
